## Background

It is observed that some of the valuable natural resources such as tin, tungsten, tantalum and gold (3TG) extracted from the Democratic Republic of Congo or its surrounding countries by appalling activities like massacre and abduction of civilians by armed forces, looting and enrolling of child soldiers. Revenue generated from selling of these natural resources used to perpetuate the fights. Procuring of such minerals from these distressed regions is equivalent to funding for these inhumane activities.

Mahindra & Mahindra Ltd. owns responsibility of materials with full deliberation and take care to avoid the procurement or usage of such Mineral in our products and services.

The term "conflict minerals" is defined as columbite-tantalite, also known as coltan (from which tantalum is derived); cassiterite (tin); gold; wolframite (tungsten); or their derivatives; or any other mineral or its derivatives determined by the Secretary of State to be financing conflict in the Democratic Republic of the Congo or an adjoining country.

### Objective

## Objective of the conflict mineral policy are

- Avoid the procurement or usage of such minerals which are unlawful or which are obtained through unethical or otherwise unacceptable means
- The company never allows any violation of human rights conducted in any part of the world for sourcing any raw materials for the manufacturing of our products
- Make sure that minerals used in our products are responsibly sourced following standards set by the Organisation for Economic Co-operation and Development and other internationally recognized human rights instruments.
- Deploy responsible procurement practises to our entire supply chain including different tiers
- It is also expected for Suppliers will have their due-diligence within their own supply chain





# Policy: M&M Shall

- Not source or use any Conflict Minerals (3TG) from DRC or its surrounding countries.
- Ensure and review compliance to conflict mineral policy

# **Policy Adherence Responsibility**

• Adherence to policy is responsibility of every person under purchasing domain.
